# The Referee's Report states: The game resumed with Northern Suburbs kicking off after a try was scored by the Swara. The ball crossed the 10-meter line, and a Northern Suburbs player caught it mid-air. However, Swara's number 15 tackled the player while he was still airborne. I immediately stopped the game to assess the situation, as the Northern player landed on his back. I issued a yellow card to the Swara number 15 for the dangerous and reckless tackle. Since this was not the first sanction given to the tackler, it led to an immediate send-off Swara Number 15. The Northern Suburbs player was then assessed by the medical personnel, and he left the field before resuming play. **ESSENTIAL ELEMENTS OF OTHER EVIDENCE (e.g. medical reports)** N/A **SUMMARY OF PLAYER'S EVIDENCE** At the Hearing hereof, in response to the Referee's sending off Report, the Player accepted to have committed an act of Foul Play, which warrated a second yellow card.

#### FINDINGS OF FACT

As per the evidence presented which stands urebutted, the player executed a tackle against an airborne victim palyer.

The player's action constitutes an illegal tackle as defined under Rule 9.17., noting the victim player's feet were off the grounnd. As provided under Rule 17.16.1 (a), the Player has admitted that the act of Foul Play was commmitted. He agreed with the fact that the act warranted sending off, being a second yellow card infringement. It is therefore my duty to determine what sanction, if any, should be imposed on the Player under Rules 17.17 to 17.21.

Noting that none of the two stand-alone incidents in quo met the red card threshold, it is my finding that the sending off was sufficient.
